


# Net Sales January-September 2000

# Net Sales By Market Area


January - September 2000





In September:


- JOT Automation Group Plc warrants were exercised for share subscription

In October:


- JOT Automation Group Plc established a system factory in Sweden
  - The System Factory will operate as an assembler and tester of the production systems for Swedish customers




# Ownership September 29, 2000




# Operational Structure



# Global Network




# Quarterly Net Sales 1999-2000
